

TOWN OF ROSETOWN

BYLAW NO. 797-18

A BYLAW OF THE TOWN OF ROSETOWN TO AUTHORIZE THE ERECTION AND MAINTENANCE OF SIGNS WITHIN ITS CORPORATE LIMITS.

The Council of the Town of Rosetown, in the Province of Saskatchewan enacts as follows:

1. That the Town of Rosetown hereby authorize the erection of “STOP” signs at the locations that set out in Appendix 1, attached to and forming part of this bylaw.
2. That the Town of Rosetown hereby authorize the erection of “YIELD” signs at the locations that set out in Appendix 2, attached to and forming part of this bylaw.
3. That the Town of Rosetown hereby authorize the erection of “NO U-TURNS” signs at the locations that set out in Appendix 3, attached to and forming part of this bylaw.
4. That the Town of Rosetown hereby authorize the erection of “LOADING ZONES” signs at the locations that set out in Appendix 4, attached to and forming part of this bylaw.
5. That the Town of Rosetown hereby authorize the erection of “ANGLE PARKING STREETS” signs at the locations that set out in Appendix 5, attached to and forming part of this bylaw.
6. That the Town of Rosetown hereby authorize the erection of “NO PARKING AREAS” signs at the locations that set out in Appendix 6, attached to and forming part of this bylaw.
7. That the Town of Rosetown hereby authorize the erection of “30 KILOMETER PER HOUR ZONE” signs at the locations that set out in Appendix 7, attached to and forming part of this bylaw.
8. That the Town of Rosetown hereby authorize the erection of “50 KILOMETER PER HOUR ZONE” signs at the locations that set out in Appendix 8, attached to and forming part of this bylaw.
9. That the Town of Rosetown hereby authorize the erection of “24 HOUR PARKING ZONE” signs at the locations that set out in Appendix 9, attached to and forming part of this bylaw.
10. That the Town of Rosetown hereby authorize the erection of “TRUCK ROUTE” signs at the locations that set out in Appendix 10, attached to and forming part of this bylaw.
11. That the Town of Rosetown hereby authorize the erection of “DISABLED PARKING AREAS” signs at the locations that set out in Appendix 11, attached to and forming part of this bylaw.
